The Legal Advisor-cum- Joint Secretary, Law and Judiciary Department, Mantralaya, Mumbai vide his D.O. Letter No. APP-4217/CR 11/D-14, Dated ~~14/2/2017~~ has invited application in prescribed forms from eligible candidates for appointment to the post of **Special Public Prosecutor**, under the **Commission for Protection of Child Rights Act, 2005 (4 of 2006)**

2. The above appointments will be purely on temporary basis and terminable at any time without assigning any reason and subject to the provisions of section 26 of the commission for Protection of Child Rights Act, 2005 (4 of 2006), Section 24 (3) of the Code of Criminal Procedure, 1973 (II of 1974) and Rule 11, 12 & 13 of the Maharashtra Law Officers (Appointment, Conditions of Service and Remuneration) Rules, 1984.

Preference will be given to eligible woman candidates.

3. **Eligibility for Appointment :-**

- 1) Applicant must be a Citizen of India.
- 2) Applicant must hold a degree in Law from any recognized university and be enrolled as an Advocate with the Bar Council of Maharashtra and Goa.
- 3) Applicant must not be more than 55 years of age on the date of advertisement.
- 4) Applicant must have at least 7 years of practice as an Advocate on the date of advertisement.

4. The applicants who desire to apply for the above posts may submit the application in the prescribed pro-forma annexed herewith. The applications should be addressed to the District Collector, District ~~Ameavati~~. The application duly filled in must be submitted to the District Collector Office by **hand delivery**.
